
All nine denominations of the French State postage due stamps were favor canceled on piece at Hanoi in 1946.

An internal registered letter from Saigon-Tandinh to Thuduc was cited as underpaid by 3 cents and charged 6 cents postage due.

French State Postage Dues Use of 10 cents

An internal letter sent from Cana, Annam to Saigon in 1944 was franked with 5 cents postage. Because the internal letter rate was 10 cents, the recipient was charged 10 cents postage due, twice the underpaid amount.

French State Postage Dues Use of 12 cents

An underpaid letter posted from Washington, D.C. on 4 March 1949 was sent to Indochina. The letter was cited for 36 cents postage due, but the addressee could not be found. The postage due stamps were nullified with a red crayon and the letter was returned to the sender.

French State Postage Dues Use of 20 cents

A 1947 letter sent from Dalat to General Delivery Saigon was charged 20 cents postage due upon arrival. The postage due amount was stipulated with a 20 cent French State postage due stamp.

Upon arrival at the end of 1946, a folded air letter sheet posted from Paris to Saigon was assessed postage due in the amount of 20 cents.

French State Postage Dues Use of 30 cents

Posted from Greece in 1948, an airmail letter was addressed to "Poste Restante" (General Delivery). If the sender had not prepaid the fee for General Delivery, the recipient was charged postage due. In this case, a 30-cent French State postage due stamp verified that the fee had been collected some three months after the letter had been mailed.

French State Postage Dues Use of 30 cents

A 30 cent French State postage due stamp was added to legitimate postage stamps on a 1948 airmail letter to the Netherlands. Upon arrival in Rotterdam the mailing was charged with 66 Dutch cents postage due.
