France's U Line connected Marseilles with the island of Reunion. After conquering it , the French maintained a significant military presence in Madagascar. As fighting intensified in Tonkin, army units stationed in Madagascar were repositioned to Indochina. Here a letter endorsed "Corps expeditionnaire du Tonkin" was properly endorsed by an officer of the unit. Since the *Caobang*, a ship hired to transport troops, had no postmark associated with the conflict in Indochina, the letter received a Madagascar Expeditionary Corps military postmark, which verified the free mail franchise.

A postcard sent from Indochina to Madagascar in 1908 was likely offloaded at the southern end of the Red Sea at Djibouti or Aden. There, the mailing was transferred to the V Line, which served Madagascar and Reunion.

CORPS EXPEDITIONNAIRE-TONKIN LIGNE V.1.

In 1893, new V Line postmarks appeared for military mail offloaded at Suez, Djibouti or Aden and bound for France. Bearing the identification "CORPS EXPEDITIONNAIRE TONKIN LIGNE V," these postmarks were applied to franchise mail from 1893 through 1904, the end of the franchise. The V Line used four numbered devices: 1 through 4. The postal agent aboard the *Iraouaddya* applied the number "1" postmark to this soldier's letter before she arrived at Marseilles on 19 June 1895.

The number 2 V Line postmark differs from the number 1 postmark in small details such as a hyphen between "CORPS" and "EXPEDITIONNAIRE" and the absence of a period after the number "2."

In this case, the *S.S. Djemnah* did not have new date plugs for "00" and continued to use its "99" for the return voyage that departed Reunion on 2 July 1899. The number 3 postmark was the least commonly used as it was in service for only three years (1899-1902).

The largest number used for the V Line postmarks was "4." Two varieties exist. For the first number "4" postmark to appear, the spacing between the "C" of "CORPS" and the "L" of "LIGNE" was similar to that found on postmarks with the numbers "1" through "3."



The type 2.314 number 4 V Line postmark exhibits a variety characterized by very close spacing between the words "CORPS" and "LIGNE". The variety is known from 1898 to 1904. Both versions were used in overlapping periods.
